



PERSONAL DATA PROTECTION LAW NO. 6698 (KVKK) SECURITY CAMERAS INFORMATION NOTICE

This information notice has been prepared by Maestro Otel Turizm ve Yatçılık Limited Şirketi ("The Maestro Hotel") as the data controller within the scope of Article 10 of the Personal Data Protection Law No. 6698 and the Communiqué on the Procedures and Principles for Fulfilling the Obligation to Inform.

Within The Maestro Hotel's usage and service areas, including common areas of our hotel, buildings and annexes, meeting rooms, waiting areas, work offices, and both indoor and outdoor common areas such as parking lots, visual recordings of our guests, visitors, and relevant individuals are collected and processed through security cameras. This is done to ensure the security of movable and immovable property, maintain physical space security, ensure occupational health and safety for employees, monitor performance, provide oversight, fulfill public service obligations, and safeguard your security, in accordance with the purposes specified in Articles 4, 5, and 6 of the Law. The recording process is conducted 24/7 via security cameras, and the recorded data is monitored by the information technology unit and the authorized company unit. The cameras record for a period of 30 days, after which the recordings are automatically deleted at the end of the retention period.

These personal data are processed automatically based on the legal grounds specified in Article 5/2-ç of the Law, which states that "it is mandatory for the data controller to fulfill its legal obligation," and in Article 5/2-f, which states that "processing of data is necessary for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject."

The personal data processed through camera recordings may be transferred, when necessary, in accordance with Article 8 of the Law, to the authorized company units, company partners/shareholders, our representatives, service providers/suppliers, judicial authorities, law enforcement agencies, and other authorized public institutions and organizations for the purpose of fulfilling obligations required by legal regulations and public services, or as evidence in legal disputes.

Requests regarding your rights under Article 11 of the Personal Data Protection Law No. 6698, which regulates the rights of the data subject, may be submitted to the data controller Maestro Otel Turizm ve Yatçılık Limited Şirketi ("The Maestro Hotel") in accordance with the Communiqué on the Procedures and Principles of Application to the Data Controller.
